

DEED OF AGREEMENT

Great Teaching, Inspired Learning Internship

(Internship Holder)

Instructions for completing this Deed of Agreement

Please read the whole of the Deed of Agreement carefully and ensure that you understand it and that:

1. your name and address in **Item 1** to the **Schedule** to the Deed of Agreement is correct;
2. **each** page of both copies is signed in **blue pen** by you and a witness, whose name and address is to be added on the signature page (page 5). The Deed must be signed in **blue pen** to ensure that all signatures are original and not photocopies;
3. you must not, of your own initiative, make any alterations to the Deed of Agreement. Please avoid doing this as an alteration will require another two Deeds being sent to you for signature;
4. you sign, date and return both copies of this Deed of Agreement. When both signed copies of the Deed of Agreement are returned, they will be checked and, if satisfactory, signed and dated by the NSW Department of Education. One copy will then be returned to you;

BACKGROUND

The Department, in response to an application by the Internship Holder, has agreed to provide employment as an educational paraprofessional to the Internship Holder during their final year of teacher training (as set out in Item 2 of The Schedule) and upon completion of a recognised teacher education program (as set out in Item 3 of The Schedule), the Department has agreed to provide the Internship Holder with a permanent teaching position (as set out in Item 4 of The Schedule).

The Internship Holder has agreed to accept the Internship provided by the Department subject to the terms and conditions of this Agreement.

AGREEMENT

The parties hereby agree that:

1. The Department will provide employment as an educational paraprofessional during the Internship Holder's final year of teacher training (as set out in Item 2 of The Schedule).
2. The Internship Holder agrees to complete a recognised teacher education program (as set out in Item 3 of The Schedule).
3. The Internship Holder agrees to:
 - 3.1 satisfactorily complete all components and obligations of the teacher education program (as set out in Item 3 of The Schedule) required by the relevant higher education institution to the satisfaction of the Department and must not defer any subjects during the course, obtain any extension or change of study without obtaining the prior written consent of the Department;
 - 3.2 continue to work in a NSW public school for 3 years (12 terms) (as set out in Item 5 of The Schedule) following the successful completion of the teacher education program (as set out in Item 3 of The Schedule) in an agreed location;
4. The Internship Holder warrants that the Internship Holder is not:
 - 4.1 an undischarged bankrupt;
 - 4.2 a barred person within the meaning of the child protection legislation and the Department's child protection policies;
 - 4.3 receiving and does not intend to receive any other financial assistance upon terms which prevent or might prevent the Internship Holder from fulfilling all obligations under this Deed of Agreement to the satisfaction of the Department; and

- 4.4 aware of any illness, disability or condition which might interfere significantly with the Internship Holder's ability to undertake and complete the teacher education program (as set out in Item 3 of The Schedule) and the three year period of commitment (as set out in Item 5 of The Schedule).
5. The Internship Holder expressly acknowledges that employment as an educational paraprofessional under this Agreement may have taxation implications and may have implications in respect of Commonwealth benefits (such as Youth Allowance, Austudy, Family Allowance and Childcare Benefits) and Commonwealth obligations (including HECS-HELP, Medicare Levy and child support).
6. This Agreement is governed by the laws of New South Wales. Each of the parties irrevocably submits to the jurisdiction of the courts of New South Wales. Any reference to legislation is to be read as including any legislative provision replacing same.
7. The Internship Holder may not assign their rights arising out of Agreement.
8. The Internship Holder will be provided with an original copy of this Agreement.
9. Any section or part thereof, or the application of any section or part thereof of this Agreement which is prohibited or which is ineffective in any jurisdiction shall only be prohibited or ineffective to the extent of the prohibition. Any section of, or the application of any section of this Agreement which is void, illegal or unenforceable in any jurisdiction does not affect the validity, legality or enforceability of the remaining sections of the Agreement, in that or any other jurisdiction.
10. The Internship Holder warrants that they have had the opportunity to seek independent legal advice with respect to this Agreement.
11. Any variation of this Agreement must be in writing and signed by the parties before it can take effect.
12. Any leave greater than five days must be endorsed and approved by the principal or supervisor and internship program manager and may affect the Internship Holder's service commitment period.
13. This Agreement supersedes all previous agreements in respect of its subject matter and embodies the entire agreement between the parties.
14. The terms of this Agreement survive its termination to the extent permitted by law.
15. This Agreement shall be binding upon the Internship Holder and their heirs, executors, administrators.
